The Facts on Eating Disorders

Youth & Eating Disorders

Americans affected by an eating disorder in their lifetime ²



- Have the second highest mortality rate of any psychiatric illness, surpassed only by opioid use disorder ¹
- Affect people of all genders, races, ages, and body sizes²
- Eating disorders are associated with:
 - Cardiac disability
 - Hepatitis
 - Cognitive Dysfunction
 - Kidney Failure
 - Esophageal Cancer

- Osteoporosis
- Infertility
- High cholesterol
- Type II Diabetes
- Death



Youth in higher weight bodies are at-risk for an eating disorder ³

80% of those who have an eating disorder are in an average or higher weight body ²



I Million Adolescents every month engage in weight control behaviors ⁴

Solution: Eating Disorders Prevention in Schools Act

- Require "eating disorders prevention" inclusion within Local School Wellness Policies
- Encourage screening for eating disorders
- Include mental health experts within the development, training, and technical assistance to schools when revising their Local School Wellness Policies through the Substance Abuse and Mental Health Services Administration (SAMHSA).
